South Boston's commercial district is characterized by compact, mostly two-story brick buildings usually possessing modernized storefronts but preserved upper-story facades highlighted with corbeled brick cornices, round-arched windows, and other decorative features. Most of the commercial buildings on South Main Street date from the 1880s and 1890s. Among the most prominent buildings of this period, and probably the oldest surviving example, is the E.L. Evans Building at 225-227 South Main Street. Built in 1888, as its central front plaque proudly declares, it is basically a Victorian Italianate brick structure defined by highly articulated brick parapets, panels, corbeled cornices, and heavy semi-circular Romanesque-like window heads. Fortunately, the original first-story storefront has been retained.

The Planters and Merchants Bank at 209 South Main Street is the most impressive late 19th-century commercial building in South Boston. It consists of a recessed, two-story central block flanked by one-story wings with semi-hexagonal facades. The central block is highlighted by a cast-iron false front featuring decorative panels, molded cornices, and a central pediment inscribed with the name of the building (P.&M. Bank) and its date of construction (1891). The first and second floors have large windows with brick arches and contrasting stone keystones and imposts, while the entire facade is enlivened with decorative brick, cast iron, and carved stone details.

Other Victorian Italianate commercial buildings include the Parkinson Block at 231 South Main Street, built in 1899 and sporting a bracketed cast-iron cornice and heavy window lintels; 235 South Main Street with its ornate brick facade; 213 South Main Street with its heavy cast-iron arched window hoods; and 425-427 South Main Street, a block of two stores, one with its original storefront, containing large upper-story fenestration with heavy lintels and an elaborate bracketed cast-iron cornice extending across the top of the building. A cast-iron segmental pediment with consoles is centrally positioned about the cornice of this building.

The entire west side of the 200 block of South Main Street consists of nine brick commercial structures with similar characteristics. Probably built in the late 1890s by the same unknown builder, the storefronts are divided by contrasting stone and brick pilasters and the buildings contain segmental-arched upper-story windows and corbeled brick cornices and parapets. A similar block of buildings is also seen in the 1000 block of Arch Street and at 519 and 521 North Main Street.

Neoclassical and Colonial Revival commercial buildings are also noted in the downtown area. Frequent fires and demolition of outdated structures allowed for the construction of some stylish early 20th-century buildings in South Boston including the brick buildings situated at three of the four corners of the intersection of North and South Main streets, Ferry Street, and Wilborn Avenue: The Municipal Building on the southwest corner of this principal intersection is a dignified two-story brick building with a rounded corner entrance framed by engaged Doric columns and surmounted by a full pediment. Several bays flanking the classical entrance are divided by Doric pilasters and feature windows with semi-circular transoms above. The second story is defined by fifteen-over-one double-sash windows with jack arches and keystones and a heavy modillion cornice. Built ca. 1910, the

most unusual feature of the building is a tall circular arcaded brick belfry situated atop the building corner; the Colonial Revival three-story brick building on the southeast corner also features classical elements such as Doric pilasters, round-arched windows, and heavy modillion cornices; unfortunately, the building has recently undergone unsympathetic alterations. The finest example of Neoclassical commercial architecture in South Boston is the former United Virginia Bank at the northwest corner of Ferry Street and Wilborn Avenue. Built in 1918, it is an impressive temple-form stone building with engaged fluted Ionic columns flanking an entrance enriched by a classical frontispiece. Ionic pilasters divide the south side elevation into bays that originally contained large windows but which are now blocked. A stone water table, full entablature with a heavy modillion and dentil cornice, and a full triangular pediment with parapet above further identifies the Neoclassical spirit of this edifice.

Other Neoclassical or Colonial Revival buildings on South Main Street are the John Randolph Hotel, a four-story brick building built in 1928, and the Raylass Building at 310 South Main Street which is distinguished by a classically inspired cast-iron front.

A late 19th- and early 20th-century residential neighborhood lies immediately to the north and east of the downtown commercial area. North Main Street above Broad Street serves as a major spine from which minor perpendicular streets extend east and west. Few residences survive from the town's earliest beginnings in the mid-19th century; however, the small one-story brick dwelling located at 1319 Hodges Street is a simple vernacular structure that was probably built ca. 1840-1850. Traditionally believed to be the oldest house in the district, the building has Greek Revival details, but an unusual shotgun-type plan.

According to an 1884 map of South Boston, by that date several dwellings stood on North Main Street as far north as Fourth Street and several existed on Broad, Ferry, Jeffress, Third, and Washington streets as well. While an impressive group of late 19th- and early 20th-century residences is found in the 1000-12000 blocks of Washington Street, the three oldest houses on the street are the most outstanding. They are the Edgar H. Vaughan House, the E.L. Evans House, and the Noblin House located at 1014, 1204, and 1002 Washington Avenue, respectively. The Vaughan House is a fine example of a Victorian Italianate residence. Built in 1888, it is a frame structure exhibiting a bracketed cornice with fanciful sawnwork, arched window moldings and hoods, and a shallow hipped roof. Further down the street is the E.L. Evans House, a late 1880s Queen Anne-style house that is unusual for its elaborately detailed porches, wide central passage plan, and combination of different building materials including weatherboards, wood shingles, and pressed brick. One of the most flamboyant Queen Anne-style houses in South Boston is the Noblin House erected in 1895 by local builder/carpenter, Jerry Walker. The well-preserved frame dwelling features a round corner tower topped by a bellcast roof, a wraparound porch with decorative sawnwork, a bracketed cornice, and wooden shingles of various shapes and patterns. A central front gable is curiously decorated with a series of wooden bull's-eye blocks.

North Main Street has always been a fashionable residential street in South Boston. Many of the town's most prominent citizens built their homes on this street beginning in the 1880s. The earliest houses tend to be Italianate or Gothic-influenced frame or brick two-story structures showing central front gables decorated with sawnwork, bracketed cornices, and long porches with turned posts and brackets. Three of the district's best examples of this type are noted at 616, 905, and 909 North Main Street and at 1330 Jeffress Street. By the late 1890s, large Queen Anne-style residences were being built along North Main especially in the 1300-1500 blocks. The R.W. Lawson House at 818, the R.S. Barbour House at 1304, the Robert H. Edmondson House at 1319, the Samuel F. Gilliland House at 1413, and the J.W. Elliott House at 1508 all share common characteristics of the style such as irregular building masses, multiple gables, corner turrets, bay windows, and wraparound porches. Some also show a Colonial Revival influence in such details as cornices, fenestration, and porch columns.

Besides its impressive array of houses representing fashionable styles of the period, the South Boston Historic District also contains vernacular houses of various types and patterns indigenous to the Southside Piedmont. The most common vernacular house type in the district is a single-story brick, or more likely, frame and weatherboarded structure invariably possessing a central front gable of varying proportions and a three-bay facade with corresponding porch extending across the front. Houses of this type are most numerous on Fenton, Second, Shepherd, and Traver streets and were built from the late 19th century into the early 1900s. Some feature decorative sawnwork in gables and on porches, but others are extremely simple with no decorative elements. The best examples include those houses at 1303, and 1400 Fenton Street, 1401 Hodges Street, 1315 Irish Street, 1318 and 1320 Shepherd Street, 1313 Wilkerson Street, 1224 Peach Avenue, 905 Traver Avenue, 820 Grove Avenue, 1119 Third Street, and 1102, 1104, and 1114 Second Street.

Variations on this house type are the one-story structures with paired symmetrically positioned front gables located at 1336 Shepherd and 1206 Sixth streets and the triple front gabled house, complete with elaborate bracketed cornices and decorative woodwork adorning bay windows, at 1223 Fenton Street. Two-story houses with central front gables are well represented in the district.

A curious vernacular house type consisting of a 1½-story frame section with an adjoining one-story wing and centrally positioned front gable is seen at 1336 Fenton Street and at 817 and 835 Traver Avenue.

Surprisingly, there are few Colonial Revival-style houses in the district, although several early 20th-century vernacular dwellings have classically inspired elements. The earliest Colonial Revival-style houses date from the 1910s and tend to be gable-or gambrel-roofed structures with columned porches, dormers, and entrances with transoms and sidelights such as are seen at 1228 Fenton Street, 900 Grove Avenue, 1010 Logan Avenue, and 1328 Shepherd Street. The more sophisticated Colonial Revival houses date from the 1920s and are two-story rectangular brick structures with symmetrically balanced facades, small porticos, a row of gabled dormers across the front, and fenestration topped by jack

arches or fanlights. The houses at 1002, 1100, and 1112 North Main Street and 1115 Washington Avenue fit this description.

Examples of the Bungalow, American Foursquare, Tudor Revival, and Spanish Colonial Revival styles are not well represented in the district; however, excellent examples of each style do exist. The houses at 1316 Hodges Street, 540 Logan Street, 903 Grove Avenue, 1612 North Main Street, 912 Randolph Avenue, 1219 and 1312 Peach Avenue and 1118 Second Street are all representative examples of the Bungalow style with their sweeping gable roofs, shed or gabled dormers, and wide porches supported by tapered square columns on brick piers. There are few American Foursquare houses in the district - 1302 and 1323 Peach Avenue, 1326 Barbours Street, and 529 Logan Street are the only true examples of the style - and only a small number of Tudor Revival or English Cottage-style houses, located at 1405 N. Main Street and 1100, 1103, 1105, 1109, and 1121 Washington Avenue. In addition, one example of the Spanish Colonial Revival style is the Tucker C. Watkins House at 1146 N. Main Street.

Institutional structures within the district include three historic churches and an early 20th-century hospital. First Presbyterian Church on North Main Street is a Gothic Revival-style brick structure with a steep cross gable slate roof, corner square bell tower, and pointed-arched stained-glass windows. The oldest church building surviving in South Boston today, it was built in 1887 and remains the most distinguished historical church in the city. Two black churches in the district are First Baptist Church on Ferry Street and Mt. Olive Baptist Church on North Main Street. Both churches were originally frame structures built ca. 1900 but were brick veneered in the 1960s. Each has square pyramidal-roofed bell towers and stained-glass windows. The Halcyon Hospital on Jeffress Street is a two-story frame building featuring a two-story front porch with an enclosed second level serving as a sleeping porch or solarium. A wide front gable decorated with sawnwork and turned posts adds charm to this 1909 building which served as a hospital until 1943.

Despite its large area and the diversity of its building types, the South Boston Historic District contains a remarkably cohesive and architecturally significant collection of industrial, commercial, and residential structures dating from the mid-19th century to the present. Few modern intrusions mar the architectural and historical integrity of the district.

STATEMENT OF SIGNIFICANCE

The South Boston Historic District is representative of the City of South Boston's industrial, commercial, and residential development from the 19th century to the 1930s. From its modest beginnings as a depot on the Richmond and Danville Railroad in 1854, the city prospered from the 1870s to become in the early 20th century the second largest bright leaf tobacco market in the United States. Preserved in the district are a wealth of tobacco warehouses, factories and prizeries as well as related commercial and residential buildings associated with South Boston's golden age of tobacco trading. In addition to its historical importance, the district is significant for its late Victorian commercial and residential architecture and for its interesting variety of late 19th- and 20th-century vernacular dwellings.

HISTORICAL BACKGROUND

South Boston traces its origins to a community established at Boyd's Ferry in Halifax County in 1796. The town did not develop as expected, however, due to occasional floods which inundated the low grounds on which it was situated.

Two major events -- the completion of the Richmond and Danville Railroad in 1854, and the construction of a covered bridge in 1858 precipitated the development of present-day South Boston. Prior to the completion of the railroad, the area contained only a few scattered residences. The arrival of the railroad in Halifax County opened the county's rich agricultural lands to the promise of eastern markets. In 1855, Captain E.B. Jeffress and the builder Josiah Dabbs constructed a brick storehouse and began a general merchandise business at "South Boston Depot" as the town became known. The following year, Captain Jeffress erected a hotel which became popular with travelers.

The Civil War halted the growth of the South Boston community. In 1870, W.B. Ellison of Milton, N.C. built the town's first tobacco warehouse and began buying leaf from growers. A second warehouse was built in 1871 by W.L. Wade who also conducted sales by public auction. Shortly thereafter, the construction of a number of other tobacco warehouses established the town as a tobacco trading center.

By 1884 the town's population had grown to 187, warranting its incorporation by the General Assembly on February 19, 1884 with the first mayor elected the following week. Prior to incorporation, the name of the settlement was changed from "South Boston Depot" to "South Boston."

The evaluation of South Boston's physical development by 1889 can be gleaned from a Sanborn Insurance Company map of the town, dated July of that year. The principal streets, Main, Broad, Factory and Ferry all had buildings that served the tobacco

industry. On Main Street were located the Edmondson Leaf Tobacco Warehouse, the Star Warehouse, the Shepherd & Edmondson Warehouse and the J.W. Easley Leaf Tobacco Warehouse. The warehouses were used for tobacco sales; therefore it is not surprising to find the town's largest hotels, the South Boston Hotel and White's Hotel, located on the same street as the warehouses. Tobacco prizeeries were found on Factory, Ferry, and Broad streets, with the largest, the Edmondson Tobacco Company prizeery located on Broad Street.

The prominence of the tobacco industry in South Boston stemmed from a number of factors. First and foremost was the town's strategic location within Halifax County, which, prior to the Civil War, had ranked near the top of the tobacco growing counties in Virginia. In addition to the growing of tobacco, the county was also the home of the Slate Seed Company, for many years the largest producer of tobacco seed in the world. The company was founded in 1867 by Major Robert L. Ragland at his Halifax Farm and by 1916 was supplying 90% of the world's tobacco seed. With the growth of the Danville tobacco market after the Civil War, South Boston's position on the Richmond and Danville Railroad linked the town with Virginia's busiest market. By 1907, South Boston had become the second largest bright leaf tobacco market in the United States with over 13 million pounds sold. The tonnage of tobacco continued to rise and the town retained its number two ranking until the Great Depression.

Fortunately, a number of buildings associated with South Boston's thriving late 19th-century tobacco industry survive. The earliest building is the Bruce family tobacco warehouse. The brick, hipped roof structure is located on the Norfolk-Southern Railroad tracks and was built during the third quarter of the 19th century by the Bruce family of Berry Hill plantation. The warehouse was associated with the Richmond-Danville Railroad and was used to store the tobacco harvested at Berry Hill before it was transported to market. It is now owned by the railroad which uses it for storage.

A number of tobacco factories survive from South Boston's boom tobacco period. The factories are located in the southern end of the district near the railroad tracks. These include the former R.J. Reynolds factory, the former Liggett-Meyers factory and the Imperial tobacco factory. The buildings are one- and two-story structures constructed in brick and distinguished by corbeling. The buildings date to the late 19th century with additions made throughout the early 20th century.

While South Boston's early development was tied to tobacco, it was not the town's only industry. The Halifax Cotton Mill was founded in 1897 as the Century Cotton Mill. The mill first manufactured cotton yarns and within four years had undergone expansion. In 1914 the mill was purchased by local businessmen and the mill's name was changed to

Halifax Cotton Mill. The industry continued to prosper and between 1924-27 added a weave room, bleachery, sewing room, warehouse and offices. The largest industrial plant in South Boston of its period, the factory is distinguished by a tower which originally served as the main entrance to the 1897 building. The mill continues to operate and is a principal factor in the damask table cloth field.

The Halifax Cotton Mill provided company housing for its workers in an area located in the southwest section of the town. The company's small, one-story dwellings were built to the rear of the factory on Summit Drive, McCanless, Bancroft, and Bermann streets. Many of the early 20th-century houses have been turned over to the workers and have been personalized through later additions and modifications.

With the tobacco boom there followed a rapid development in the town's commercial district. The 1889 Sanborn Insurance Company map indicates a number of small commercial buildings that included a bank, groceries, jewelers, a drug store, barber shop and bakers. Main street still boasts the town's heaviest concentration of commercial buildings, the earliest dating to the late 1880s and 1890s.

When it was built in 1888, the E.L. Evans Building was undoubtedly the most stylish storefront in South Boston. The two-story brick edifice is distinguished by an ornamental pressed brick cornice, the center plaque bearing the name, "E.L. Evans" and the date "1888." Presently abandoned, the structure retains its architectural detailing and integrity. Built within a few doors south of the Evans Building is the Planters and Merchants Bank of 1891. It stands as one of the most opulent structures in the commercial area and clearly reflects the prosperity of the tobacco planters and merchants who established it. Like the earlier Evans Building it has a pressed brick cornice and arched openings. It presently serves as an antique shop. Constructed adjacent to the Evans Building, the Parkinson Block was built in 1899. While its first-story facade has been altered, the structure retains its second-story lintels and cast-iron cornice. Its two-story height is typical of the turn-of-the-century commercial structures found on South Boston's Main and Arch streets and Wilborn Avenue, the core of the business district. A notable exception to the scale is 441 South Main Street, a three-story building. It is distinguished not so much by its cornice or elaborate brickwork, but rather its arched openings. The somewhat irregular corner site contributes greatly to its distinctive appearance.

For the most part the town's later 20th-century commercial buildings have retained the two-story scale established by the late 19th-century structures. In fact, many of the 20th-century buildings have corbeled brick facades, reminiscent of the older 19th-century stores. Unfortunately, insensitive changes have been made to several first-story facades.

The chief landmark of the commercial district is the South Boston Municipal Building located at the corner of Main and Ferry streets. The imposing "U"-shaped building, erected in ca. 1910 epitomizes the town's rapid turn-of-the-century development. The main entrance is executed in the Neoclassical style, then the preferred style for civic architecture. An unusual feature is the circular belfry, which has lost its bell. Across the street from the municipal building is another Neoclassical building, the former United Virginia Bank Building of 1918. The bank with its temple form stands as the town's best example of 20th-century classicism.

Immediately adjacent to the late 19th- and early 20th-century commercial area is an architecturally interesting residential neighborhood which arose in the same period. Its houses represent a variety of building styles, reflecting varying economic levels of South Boston society.

What is traditionally believed to be the oldest house in South Boston and the district is the dwelling at 1319 Hodges Street. Built ca. 1840-1850, the one-story brick structure is South Boston's best example of vernacular Greek Revival. While other earlier dwellings may still survive incorporated within later structures, 1319 Hodges remains the only free-standing house in the district dating from the period of settlement.

A number of residences which were indicated on the Sanborn Insurance Company map as standing in 1889 remain in the district. Especially notable is a cohesive collection of late Victorian dwellings on Washington Avenue. The houses include late Italianate-style and Queen Anne-style residences. In this regard, the best example of a wood frame Italianate house is found at 1014 Washington Street. Its arched window hoods and bracketed cornice clearly distinguish it from similar houses of the same period within the district. Likewise, the E.L. Evans House at 1204 Washington Street is a fine representative example of the Queen Anne Style at its best. Built during the late 1880s, the imposing residence features elaborately detailed porches, pressed-brick ornamentation and an exceptional interior. The hooded pressed-brick fireplace in the main entrance hall, together with the interior woodwork, ranks this dwelling among the best of the Queen Anne style in Virginia. On the same block, 1002 Washington Street also stands as a classic Queen Anne residence. It has a fanciful first-story porch, corner tower and stained-glass windows. Fortunately, the house has been sensitively restored.

North Main Street has always been considered a fashionable address in South Boston. Much longer than Washington Avenue, it has an assortment of late 19th- and early 20th-century residences. 1319 North Main Street is a stylistically eclectic residence that shows the influence of the French Romanesque on the domestic architecture of South Boston. Its stone lintels, pyramidal-roofed tower and corbeled chimneys contribute to the architectural sophistication of this turn-of-the-century dwelling. Unfortunately, as is the case with much of the architecture of South Boston, the architect is not known. The Queen

Anne style is also well represented on North Main Street. Varied examples may be found at 1304 N. Main, 1314 and 1413 North Main. The residences date to the turn of the century and were constructed on a very grand scale reflecting the town's prosperity at that time. North Main also boasts significant and varied examples of the Colonial Revival. The former Tucker C. Watkins House at 1146 North Main along with the residences at 1002 North Main and 1421 North Main are among the most important examples in the district. All were built before the Great Depression and reflect the town's prominent role in Virginia's tobacco and textile industries.

The historic district also includes numerous examples of the Bungalow style, American Foursquare and builders' vernacular. South Boston's mixture of very stylish residences with less ornate examples was noted by Wirt Johnson Carrington in A History of Halifax County, published in 1924:

"The streets are bordered with beautiful homes, large and small, old and new; some with extensive grounds ornamented with shrubs and flowers, others with greensward and forest trees, decorative plots of beauty everywhere, each vying with the other in attractiveness; and in the midst of it all activity and life, evidences of a growing town."

Fortunately for South Boston, growth has meant the preservation of the town's older buildings, resulting in the present historic district, one of the largest and architecturally interesting in Southside Virginia.



Boundary Justification

The South Boston Historic District generally contains the largest concentration of historic buildings in the city dating from the mid-19th century to the 1930s. The industrial area located in the southwestern region of the district contains the entire Halifax Cotton Mill/company town complex, excludes a wooded area between the railroad warehouse area and the company town, and includes all the historic buildings associated with the tobacco industry on both sides of the railroad and along Ferry Street, Factory Street, and Seymour Drive.

Nearly all of the downtown commercial area of South Boston was included in the district along North and South Main streets and Wilborn Avenue. Areas to the south and east of the 100 block of South Main Street as well as on both sides of Broad Street were excluded from the district because of the large number of vacant lots, parking lots, and noncontributing buildings in these areas. The area north of the 700 block of Wilborn Avenue was also excluded due to a large number of noncontributing buildings.

The residential area of the district extends primarily along North Main Street and as far north as the 800 block. North of the district's northernmost boundary is an area with fewer concentrations of historic buildings and a large number of vacant lots. The residential area east of the district boundaries on Moore, Hodges, Irish, and Fenton streets as well as the residential area west of North Main, Washington, and Third streets contain mostly noncontributing buildings. A small residential area south of Third and Logan streets was excluded from the district because it contains mostly buildings dating from the 1950s. The residential area northwest of Ferry Street was excluded from the district. It also contains a large number of noncontributing buildings, vacant lots, and several dilapidated structures of compromised integrity.






