STATEMENT OF SIGNIFICANCE

The grave of Major William Gooch is marked by the first documented decorated tombstone in the English colonies and the second oldest legible stone in Virginia. [REDACTED]

William Gooch, who was a Burgess from York County, was appointed to the Council in March, 1655, the year he died at the age of 29. He is believed to be the William Gooch listed in Burkes' Peerage who died in 1655 and was the uncle of Sir William Gooch, acting governor of Virginia 1727-49.

York Village was the forerunner of Yorktown, which was established two miles to the west in 1691. This area of land was first patented by Governor John Harvey in 1631, when he acquired 750 acres called York Plantation, adjoining Wormley Creek. Harvey's land passed through various ownerships until 1768 when it was purchased by Augustine Moore, whose house was the scene of the drafting of the Articles of Capitulation of the British Army in 1781.

On the land around the Gooch tomb was established the first settlement on the York River, variously called "York," "Old York," and "York Village." Court was held here as early as 1635, and in 1658 Captain Robert Daldrey's residence was rented as a courthouse. In 1662 a dunking stool was built near the place "where it is supposed the town for York River will be built." A prison, stock, and pillory were built in the same location. York Village had a minister in 1638, and in 1667 was built a new church whose walls, like the one that preceded it, surrounded Gooch's tomb.

[REDACTED] Bishop Meade wrote in 1834 that the walls were still standing to a height of several feet. It is believed that Henry Howe was describing then visable remains of York Village when he wrote in 1846 "about a mile and half below Yorktown, on what is called the Temple Farm, are many old chimneys, indicating the site of an early settlement."

In 1861, Confederate General John B. Magruder was given the responsibility of defending the Lower Peninsula against an invasion toward Richmond. Magruder constructed a defensive line of earthworks across the Peninsula, making use of some existing Revolutionary War embankments at Yorktown. The trenches east of the Gooch tomb were a part of the 1862 fortifications.

Archaeological excavation could determine the extent of the remains of the Colonial settlement, and perhaps provide further information about life in Virginia in the seventeenth century.

7. The original William Gooch Tomb and York Village Archaeological Site nomination prepared in 1973 encompassed 20 acres. Within the nominated area are three contributing resources - the 1655 limestone slab tomb of Major William Gooch, the seventeenth-century settlement of York Village, and Civil War trenches dating to 1862. Archaeological testing in 1993 (see section 8) documented that these three resources are restricted to four acres, thereby reducing by 16 acres the National Register boundaries for this nomination.

8. [REDACTED] All of these properties are contributing resources within the original nomination and are included within the proposed boundary reductions. Area eliminated from within the boundaries is restricted to locales shown to not contain archaeological deposits or surviving Civil War earthworks.

Archaeological testing of the York Village site (which includes the Gooch Tomb) was conducted in 1993 to determine the boundaries of the site (see McSherry and McCartney 1993). The testing consisted of excavating and screening shovel test holes at 50 ft. intervals throughout the site area as determined by previous survey and excavation (see Outlaw 1974 and Smith 1978). [REDACTED]

A Civil War fortification, part of the Union Army defensive works erected in 1862, is visible along the north edge of the main site area. No artifacts related to the Civil War were encountered during the 1993 archaeological testing (McSherry and McCartney 1993). No shovel test holes were placed into the trench itself, although shovel test holes were excavated on the south side of the trench (see McSherry and McCartney 1993:Figure 23). Areas to the north have undergone extensive modern disturbance. The visible and intact portions of the berm-and-trench begin at the northeast corner of the York Village site near the east corner of two tennis courts to the north for a length of approximately 60 ft. The trench is then interrupted by Perimeter Road and another tennis court. The intact berm-and-trench reappears on the south side of Perimeter Road. This portion of the fortification extends for approximately 400 ft. It ends near a "fitness station" and a disturbed area around a generator station. A walking path and fitness trail parallel the 400 ft. section of earthworks. The proposed boundary reduction includes all of the surviving berm-and-trench with an additional 20 ft. to both the north and south.

Verbal Boundary Justification: Area encompassed within this boundary decrease is restricted to the three contributing resources within the original nomination - the 1665 line, the 1860 trench, and the 1860 trench. These boundaries were established through above-ground observations of surviving resources and archaeological subsurface testing. Area eliminated from within the boundaries is restricted to locales shown to not contain archaeological deposits or surviving Civil War earthworks.

Archaeological Field Work at the Site/Garrett Fessler, James River Institute for Archaeology, Inc.

As requested by the State Review Board, Garrett Fessler, James River Institute for Archaeology, Inc. (JRIA), prepared the attached map showing all positive and negative test units excavated by JRIA in 1992 at the Gooch Tomb/York Village National Register property in York County. Also enclosed are supplementary comments provided by Fessler. The proposed boundary reductions are consistent with the archaeological documentation.

The artifacts recovered from each of these ten positive shovel test holes consisted of single prehistoric lithic flakes or prehistoric pottery sherds from disturbed contexts, 20th-century debris, or non-diagnostic brick crumbs. None of these artifacts was related to the 17th-century or Civil War components of 44YO17.

The area immediately south of the easternmost Civil War earthworks was badly deflated by heavy machinery and was not tested due to standing water at the time of the survey.

Shovel test holes were not excavated to the south and west of the site area because that area had been thoroughly surveyed in 1992. At that time no historic or prehistoric artifacts were recovered from 49 shovel test holes excavated at a 20 ft. interval. The report entitled "Archaeological Testing of a Proposed Office Building Complex at the United States Coast Guard Reserve Training Center, Yorktown, Virginia" written by Garrett Pesler and Nicholas Lucchetti is on file at the James River Institute for Archaeology, Inc.
