ARCHITECTURAL DESCRIPTION

Summary

The Kennedy-Lunsford Farm, located in northeastern Rockbridge County in western Virginia, includes a limestone farmhouse which represents the first wave of permanent architecture in the Shenandoah Valley. Located along state Route 606 (Raphine Road) between the historic villages of Brownsburg and Raphine, the Kennedy-Lunsford Farm occupies an unspoiled site located amidst rolling hills. It is surrounded by wooded tree lines which shelter views in all directions from any neighboring structures and roadways. Besides the vernacular Georgian dwelling, there are five contributing farm buildings including a large bank barn, a corncrib/machinery shed, a springhouse, a chicken coop and a syrup house, all dating from the early twentieth century. The house rests near the center of a 139 acre hilly site consisting of hay pastures and wooded areas. Five streams are located on the property, one of which runs near the house to the north into a pond. Split rail fences line the meandering farm lane.

The main residence is a three-bay, two-story stone dwelling with a gable roof and interior end chimneys. It originally had a hall-parlor plan that has been altered through its history by several different owners. A single-bay, gabled-roof porch is centered around the single front door with transom. A two-story, frame, rear ell projects from the rear elevation of the stone house.

Detailed Description

The house is one of the few remaining limestone dwellings of its type dating from the late eighteenth to the early nineteenth century in Rockbridge County. On the exterior, this two-story, three-bay dwelling has walls laid in coursed stone rubble with repointed mortar joints and flat arches above each window opening. The replacement windows have architrave surrounds and are nine-over-six double-hung sash on the first floor level and six-over-six double-hung sash on the second level. Sometime during the late nineteenth century, the original windows were replaced with two-over-two double-hung sash. The windows were restored to their original configuration in the 1976 when the historical architectural firm, the National Heritage Corporation, rehabilitated the dwelling. The single six-panel

front door has a four light transom. The basement level features single-light windows with replacement wood security bars on the front elevation and a single nine-light window on the west side, north of the rear ell.

A one-story, single-bay, front porch, based on historical precedents, was added during the restoration. It features paired, chamfered wood posts which support a roof gable containing horizontal board siding. A continuous molded box cornice runs along the front and back elevations of the house beneath the roof line. Tapered end beaded rake boards project to interior chimneys which are located at each end of the gable form. The north gable end contains four-light casement windows on each side of the chimney. The gable roof has wood shingles and is supported by a mortised-and-tenoned rafter support structure.

Also set upon a coursed rubble limestone foundation is the frame rear ell. This two-story addition is clad with beaded weatherboard siding and like the main block of the house, has nine-over-six double-hung sash windows on the first level and six-over-six double-hung sash windows at the second level and a continuous boxed cornice.

Vacant and in poor condition, the house had lost almost all of its interior Victorian-era woodwork, original central staircase, and later front porch when the present owners acquired the property in 1975. Much of the interior plaster was gone and a fire had severely damaged the floors and some of the structural system. The new owners completely restored the exterior to its eighteenth-century appearance and carefully updated all interior spaces; the historical architect, Norman Askins, studied other similar nearby stone houses for various design precedents. A brick terrace was added to the north of the house with a connecting brick walk on the west side leading to a gravel parking area. A new stair was added in the rebuilt ell where the new kitchen, bathroom and dining area were placed.

The original plan appears to have been hall-parlor with the stair located between the two spaces. At some point in the nineteenth century, the parlor was divided into two smaller rooms. It is possible that a wall was added to the hall space to create a central hall. All of these interior walls and the stair were missing by 1975 when the Griswolds purchased the dwelling.

During the restoration, the floor was patched where the original central stair had been removed. A second, side later replacement ladder type stair was also removed from the original section of the house and access was provided to the second floor through the rebuilt rear ell addition. Random width beaded board walls and doors were installed at each end wall and both fire boxes and hearths were rebuilt. Chair rail matching an existing profile on the second floor was also installed on the first floor in this area. All existing plaster was patched and new plaster was made to match the existing during this work.

As the house now stands, the basement level is divided into two areas--one beneath the rear ell and the other under the original section of the house. The area below the rear ell contains a wine cellar and provisions area with a closet as well as an area of unexcavated crawl space. The original kitchen with large cooking fireplace opening and wood lintel is located in the basement beneath the original section of the house and is now used as a study. Bookshelves are located on either side of the fireplace.

On the main level, the original section of the main house serves as a living room off of which the rebuilt rear ell projects. Contained within the ell are a stair hall and laundry space, two small closets, and a kitchen/dining area at the northern most end. Double doors lead from the ell onto the brick terrace. On the second floor, a new bath was incorporated into the rear ell off the stair hall and which leads to a rear bedroom. A second bath was located in the front original section of the house and serves the other two upstairs bedrooms.

In addition to the main house, there are five contributing outbuildings on the site. Dating to 1910-1911 and located to the southeast of the residence, the bank barn is a weatherboard clad building with a standing-seam metal gable roof and sliding vertical board doors. The second level projects beyond the lower stalls creating a continuous overhang on all sides. A lattice work vent is located beneath the eaves on the front and rear elevations while a diamond shaped lattice vent is located on the gable ends with vertical vents beneath each. The north elevation features five stall doors at the first floor level. A continuous vent is located above the corrugated sliding doors on the south elevation. On the interior the barn is

divided into four bays by three sets of mortise and tenoned, circular sawn posts with braces supporting the gable roof structure above.

The syrup house, located across from the bank barn to the south, is a one-story frame structure clad with vertical board siding and features a standing-seam metal gable roof with a monitor in the center and exposed rafter ends. A one-story, frame shed roof addition was made to the northeast end elevation. The east elevation has two slotted vents.

Directly west of the syrup house is the chicken house. Covered by a shed roof with exposed rafter ends, this building has banks of windows with four vertical lights in each, is clad with weatherboard siding, and rests on a poured concrete foundation.

The corncrib/machine shed is sited south of the house and is composed of two sections. The original two-story frame section of the building rests on a poured concrete foundation and has a standing-seam metal roof. A one-story, shed-roofed addition with large openings for vehicle storage was added to the south side of the crib in 1945, according to a date on its concrete foundation. Both parts are clad with vertical board siding on the east elevation and horizontal wood siding on the west, south, and north sides. A small section of the addition has a coursed stone foundation. On the interior, the space is divided into a four foot wide corn crib on the east side and five grain stalls on the west with a loft above. All the interior wood members have circular saw marks.

A frame springhouse with weatherboard siding and a standing seam metal roof is located on the other side of the house to the north, next to a small creek. A single vertical-board door is located on the south elevation of this small building.

The present owners have added a variety of trees and plantings throughout the farm around the house and a garden between the house and the springhouse. A small orchard with fruit trees has been planted near the creek which spills into a small pond beyond the springhouse.

STATEMENT OF SIGNIFICANCE

Located in the heart of the Shenandoah Valley in the northeaster corner of Rockbridge County, the Kennedy-Lunsford Farm is historically significant as a rare surviving vernacular Georgian farmhouse of the late eighteenth century. It is one of the few examples of this early form executed in limestone in Rockbridge County. The dwelling with its later outbuildings retains much of its original character and integrity. Its setting is pristine and unspoiled: a combination of pasture land, hay fields, five springs and rolling hills capped with wooded ridges. The house and its surroundings are completely shielded from surrounding buildings and roads by a perimeter of wooded tree lines and thus retain the historic ambiance of the Kennedy-Lunsford Farm. Located between the historic villages of Brownsburg and Raphine, the farm is a part of the large land tract originally owned by Andrew Kennedy, who also owned the Kennedy-Wade's Mill near Brownsburg.

Historical Background and Significance

While once a prominent house type, the hall-parlor plan is represented by only a handful remaining examples of its type in Rockbridge County. The plan which consists of two rooms with an exterior chimney at each end is represented by thirty-nine ante-bellum examples in the Rockbridge County area. Of these, only four surviving examples are constructed of stone according to an unpublished manuscript by Pamela H. Simpson of Washington and Lee University.¹ The Kennedy-Lunsford house was most likely a hall-parlor plan dwelling with a central stair.²

During the Lunsford family ownership, there were three rooms--a hall with the central stair to the south end and two smaller rooms on the north. According to Pamela Simpson, the configuration of the Kennedy-Lunsford house is quite similar to other hall-parlor plan houses located in Rockbridge County. Simpson also indicated that the three room plan was also a commonly used plan type for stone houses in Rockbridge County. Thus, the Kennedy-Lunsford is, most likely, one of only four extant hall-parlor plan stone dwellings or, less likely, one of only three eighteenth century examples of the three-room plan type, but the two chimneys suggest a hall-parlor plan.

The land of the Kennedy-Lunsford Farm was first granted to Benjamin Borden from Virginia colonial governor, William Gooch in 1739. Borden's heirs sold 341 acres to Andrew and John Kenady (Kennedy) in 1762 and it appears Andrew Kennedy gave his son, Joseph, approximately 200 acres prior to the son's marriage in 1793.³ There was a significant tax increase in the property between 1796 and 1797 which may indicate the time frame in which the house was constructed. The 1796 entry was the earliest year recorded for Joseph Kennedy's district in the land tax book. It is possible that the house was built in that year, though it is more likely that Kennedy was already residing on the tract prior to 1796. Some tithable books exist for the district and Kennedy appears on them from the earliest date of 1792. In that year, he was listed as a land owner and was taxed on one white male over sixteen and two horses. This entry remains unchanged until 1797 when one black male over sixteen and three additional horses were added.⁴

The Kennedys were Presbyterian Scotch-Irish and early settlers in the frontier of Augusta and Rockbridge counties in the mid-eighteenth century. Members of the family served in the militia and helped form local Presbyterian church congregations.

Although Joseph Kennedy died in 1819 or 1820, the land remained in the family until 1847 when they sold the property to Robert Harris.⁵ Robert Harris, Sr. purchased the land from John Kennedy, and his wife Elizabeth, as well as Mary Kennedy on 26 November 1847 for \$2,700. The land was described as containing 232 1/2 acres and as recently surveyed by John Wothrow.

The property was transferred within the Harris family from Robert Harris, Sr. to Robert Harris, Jr. and finally to Sarah (Sally) Harris.⁶ Sarah Harris received the land from her son, Robert C, Harris. The property contained two tracts of land one 132 acres and the other 61 1/4 acres.

The Harris Estate was settled by public auction and sold to N. David McCormick in 1876.⁷ In 1891, N. Davis McCormick sold the farm to William Lunsford in whose family it remained until 1958 when it was sold to Sue Ann Gudal.⁸

Through much of the twentieth century, the house was known as the Old Lunsford House. James Lunsford, whose death eventually put the house into the hands of Avis Lunsford, purchased the house from William and Susanna Lunsford on 20 June 1892.⁹ He paid \$2,000 for the 140 acres, 145 poles located in the Walkers Creek District.

William and Elderine Campbell obtained the property from Avis H. and Lillian Lunsford on 20 November 1958, who had received the property in the early 1920s through a series of inheritance conveyances after the death of James Lunsford.¹⁰ The Gudals, in turn, purchased the land from the Campbells on 26 January 1973. At that time the property was 140 acres and 145 poles.

The current owners, Mr. and Mrs. Grant H. Griswold purchased the farm in 1975 from Sue Ann Gudal.¹¹ The tract at that time consisted of 136.71 acres and the new owners purchased three additional acres along Raphine Road to the entrance of the farm. Upon purchasing the property, the Griswolds retained the historic architecture firm of the National Heritage Corporation to restore the exterior and adapt the interior of the house to modern living.

Maintaining integrity of setting, location, and feeling, the Kennedy-Lunsford Farm house is a notable extant example of the first permanent domestic architecture to be built in the Shenandoah Valley. Though no original outbuildings remain, the

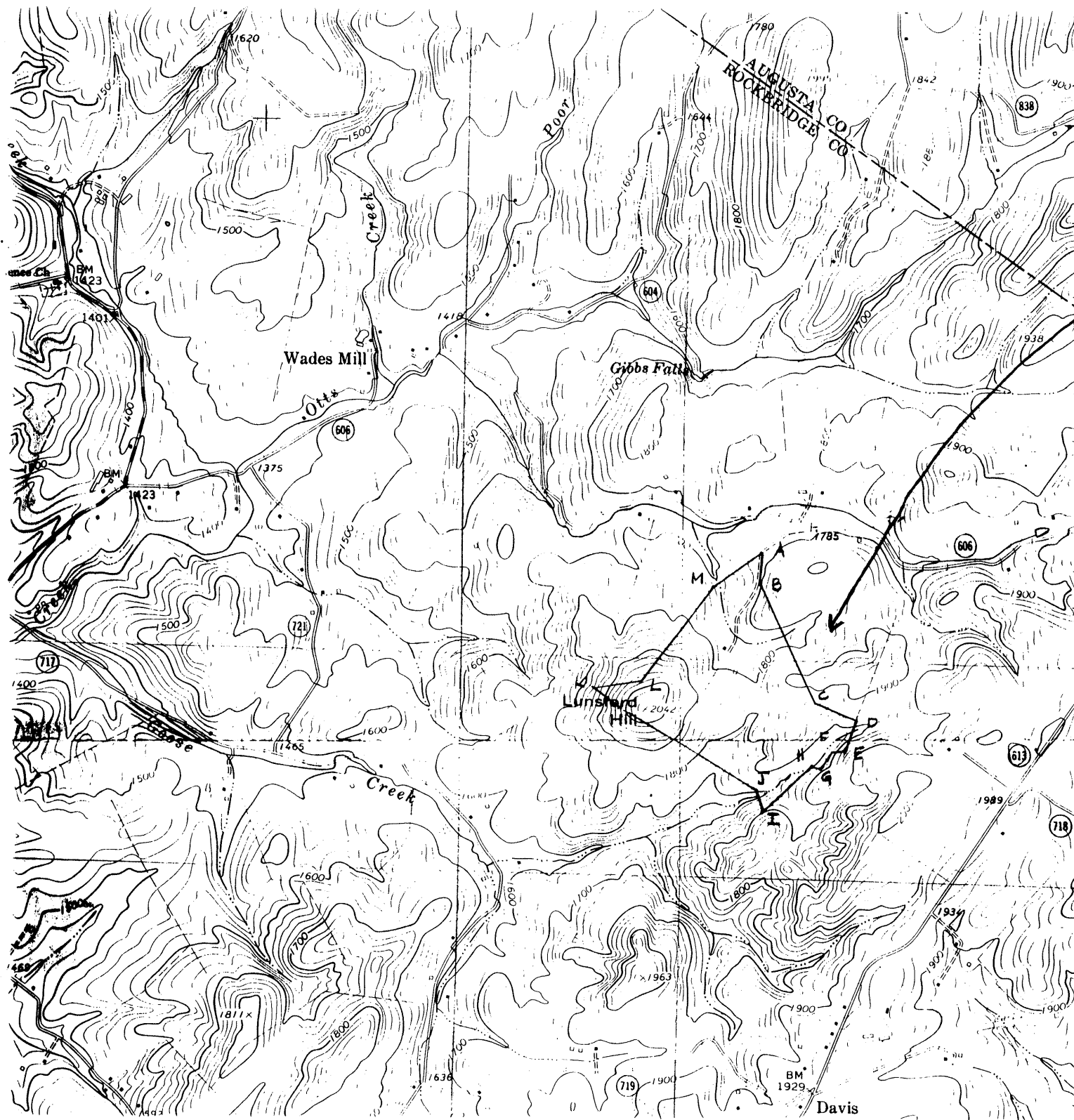
