The original appearance of Battersea must be a matter of conjecture as the house underwent significant alterations in the early-nineteenth century. As one authority noted, however, these did not alter the basic integrity of the original design. The house is built on a five-part plan, having a two-story central block, one-story hyphens, and two-story pedimented gable end pavilions. The central block is covered by a pyramidal roof with a carved pineapple at its apex. Apparently the central block was fronted by a two-level portico as evidenced by the break in the cornice. The present one-story porch appears to date from the alterations although early materials may have been used. The finely executed dwarf porticoes at the ends of the building are original. Other alterations to the exterior include the stuccoing of the Flemish bond brick walls, the insertion of the Palladian windows in the end pavilions and three-part windows in the hyphens, and the installation of the fan-and side-light front entrance. The window arrangement on the rear of the house appears to be original although some of the windows may have been enlarged.

The plan of the house survives intact, however some of the original woodwork has been lost. The entrance hall retains its magnificent Chinese trellis stair and its original paneling. The paneled dadoes survive in the west pavilion and hyphen as well as in the drawing room, more properly known as a saloon.


