Briefly describe the property's overall location and setting, including any notable landscape features:						

Pleasant View School sits on the South side of River Road, west of its intersection with Cedar Creek Road and about a mile and a half from the entrance to Eppington (VLR, NRHP 1969). The two-acre lot has 210 feet of road frontage and is 420 feet deep. The school faces River Road to the north, with a moderate setback at the end of a gravel driveway. The rear of the lot is largely wooded; a privy was historically located south of the school but is likely no longer extant. The surrounding area is predominantly rural, consisting of low-density residential development interspersed with wooded areas and open fields.

Pleasant View School is a one-story, three-bay, two-room frame schoolhouse constructed in 1930. The exterior retains its original board siding, and the building is covered by a hipped roof clad in original crimped metal and featuring wooden rafter tails. Primary entry is centered on the north elevation and consists of a hipped roof vestibule containing an original paneled wood door flanked by square, four-light wood sash windows. Paired, six-over-six wood sash windows flank the entry bay on the facade, with two single six-over-six windows on each side elevation. An interior central brick chimney extends from the intersection of the main roof and the vestibule.

While not a Rosenwald school, the design of the building is representative of rural African American schools of the period and bears similarities to the Rosenwald two-teacher community school plans. The interior of Pleasant View retains its original wood floors, walls and ceilings clad in beadboard, an original blackboard in one of the rooms, and several original desks. The two classroom spaces are also divided by a movable partition that remains intact.

The building was moved approximately 60 feet east of its original location (within the same parcel) following a property dispute in 2007-8. The relocation resulted in the construction of a new brick pier foundation and new front entry steps, as well as the replacement of rotted joists, sill, and siding at the entrance. Despite the move, Pleasant View retains its original orientation and overall relationship to the site and surroundings.

## 4. Property's History and Significance (Please do not exceed one page)

Pleasant View School is one of the last African American elementary school buildings from the segregated era still owned by Chesterfield County. Its design is representative of local schools constructed in the style of the Rosenwald Schools built in that era. African American residents indicated they attended a schoolhouse near the current location as early as 1914. Many believed there was a school there as early as 1900.

The Chesterfield County School Board purchased the two-acre lot from Peter J. and Linnie Lee in 1924. On January 29, 1930, the school board approved the consolidation of the existing Pleasant View and Winterpock schools. The Board agreed to build a new schoolhouse provided that the patrons donated \$300.00 and the land at allocation agreeable to the patrons of both schools. On March 26, 1930, the board rescinded the action and approved a two-room building instead, citing the inability of the patrons of Pleasant View and Winterpock schools to agree to consolidation. The following month, the board accepted the low bid from C. H. Besecker to construct Pleasant View for \$1,338.22. The school was completed in September 1930 and opened for the 1930-31 school year.

During the transition from the old schoolhouse to the new one, Mary Crawley Brown, teacher and principal at Pleasant View for many years, taught classes in her home which still stands nearby on River Road. Other teachers included Alva Patron, Georgia Butler, Lucille Archer, and Gertrude Finn. Ms. Butler also taught night classes for adults who lived in the area.

In the early 1930s, Rev. Willie Matthews held Sunday bible classes at Pleasant View when weekly services were not held at nearby Tabernacle Baptist Church. Over the years, two different congregations met at the school for services. Evidence of church activity remains with the presence of several pews currently in the building.

Pleasant View was closed at the end of the 1946-47 school year. Following the closure, the Pleasant View Community Association received permission to use the school building as a community center. The Community Association used and maintained the building as a center of community activity from 1947 until 1998, when it was sold.

The building was historically used by B & B Hunt Club, the Chesterfield Braves Baseball Club, the Imperial Order of King David Lodge #64, as well as 4H and Home Demonstration classes. In addition, it was used for dance parties and fundraisers. The King David Lodge paid for the installation of electrical lights in the 1950s.
